CONDITIONS OF HOMESCHOOL ENROLLMENT

I/we understand and agree to the following:

- I must have a valid email address that is checked regularly.
- All information submitted is true to the best of my knowledge.
- All applicable registration fees are due before my student is officially enrolled.
- <u>NO CURRICULUM IS INCLUDED IN THE COST OF ENROLLMENT.</u> Curricula, books, testing, evaluations, tutoring, classes, field trips or any other educational resources are my responsibility.
- Although I may withdraw my student at any time, <u>ALL FEES ARE NON-REFUNDABLE.</u>
- All required or requested forms must be completed in a timely manner in order to finalize my student's enrollment.
- My student's acceptance does have compulsory attendance requirements of 180 days per year and specific graduation requirements.

- Reporting grades and attendance is required in order to comply with state and school mandated policies. Grades and attendance are required by January 15 and June 15 of each school year. If submitted after the deadlines, late fees will apply. Extensions may be granted upon request; however, if an extension is not requested, late reporting fees may apply or my student may be withdrawn.
- Failure to meet any of the above-listed requirements may result in withdrawal. Records will be sent to another school only after all fees have been paid and requirements have been met.
